The following are the results of the 2025 Municipal Election for one 4-year term Mayor, two 4-year term City Council Seats, and one proposition.

In the race for **Mayor (4-Year Term), Vote for one:**

**Don Busenbark** received 464 votes (42.34%)  
**Tommy Kent Olsen** received 632 votes (57.66%)  
**Under Votes 15**

This results in Tommy Kent Olsen being elected to fill the position of Mayor.

In the race for **City Council (4-Year Term), Vote for two:**

**Rowdy David Cloward** received 563 votes (28.69%)  
**Preston David Kadleck** received 450 votes (22.94%)  
**Beau Dean Hancock** received 550 votes (28.03%)  
**Brandon Guy Hollenbeck** received 399 votes (20.34%)  
**Under Votes 260**

This results in Rowdy David Cloward and Beau Dean Hancock being elected to fill the two open seats on the City Council.

Proposition 16 ZAP Tax


**For the ZAP TAX** received 763 votes (69.68%)

This results in For the ZAP TAX being voted in favor of.


